Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in a calendar year. UMA Motorcoach Travel PAC uses member contributions to help elect individuals to federal, state and local office who support our organization's goals. Contributions from foreign nationals (other than those individuals lawfully admitted for permanent residence), corporations, national banks, federally chartered corporations, federal contractors and labor unions are prohibited. UMA Motorcoach Travel PAC may not accept more than \$5,000 per year from any one contributor.
